- 5. Entries must remain for the entire show. (NO EXCEPTIONS)
- 6. In the event of a sale the artist will donate 20% to the Cultural Center.
- 7. Payment of a \$10.00 entry fee will be collected at registration.

Only 2012 members are eligible for the show. You must have paid your dues for 2012 before November 2012 meeting to be eligible. No late entries accepted.

<u>PLEASE REMEMBER</u> to complete your registration forms <u>BEFORE</u> you come to register. There are three small forms on one sheet of paper. (Pg 3) You keep one and place one on the back of the artwork and TSAA keeps the third.

depths of color, value and shapes that engage the artist as well as the viewer, allowing for individual interpretation and a relationship to the art's expression.


